#### LOCATION

Perthybu Wood is situated just over the Welsh border in the county of Powys. Montgomery is 4 miles to the north and Newtown 8 miles to the east. All distances are approximate.

#### DESCRIPTION

Perthybu Wood is situated near to the historical town of Montgomery, established in the 13th century around a Norman castle built to control an important ford over the nearby River Severn. The bustling market town of Newtown provides the key amenities.

The wood sits on a warm south facing hillside amongst the beautiful rolling countryside of Powys. Its shape is long and narrow which follows the contours of the hill running east to west. The topography is generally sloping with flatter areas and sits at an elevation from 200 to 350 metres. The area receives rainfall of circa 1300mm annually. The soil is a rich brown loamy clay, which is reasonably fertile, retains moisture and is highly suitable for growing trees.

The woodland is well roaded with a main hard surfaced track running much of the length of the wood suitable for HGV access. There is also an excellent network of unsurfaced but firm tracks throughout. These tracks are suitable for 4-wheel drive vehicles and have been maintained in order to extract timber. The quarry in the wood has been used to build and maintain the forest roads and appears to be capable of providing further stone to maintain them should it be needed.

Perthybu Wood has been in regular management for at least 60 years and now presents a variety of coupes of different ages. The trees are principally conifers with a good diversity of broadleaves which are found in small groups and mixes. Of note you will find oak and beech as well as small amounts of ash and willow. The conifer crops consist of Scots pine, Douglas fir and Sitka spruce. Felled areas have been ground-prepped and replanted with Norway spruce and Douglas fir. These trees were planted to a high standard with improved tree stock and have received their prescriptive management to date.

The mature crops include Scots pine and spruce. Both recently received their first thinning and are on their way to producing a final crop in 20 and 10 years respectively. There are small areas of mature Douglas and spruce aged over 40 years that have been retained for aesthetics and value.

There are fringes of mature broadleaves in the lower sections and in naturalised areas. These retain aesthetics and vibrance to the woodland and balance the commercial planting with a nod to mother nature. To the west there is a wide gully that crosses the wood. This is classified in part as Restored Ancient Woodland and in part Plantation on an Ancient Woodland.

To the northeast there is a 10 acre unstocked coupe at elevation that has exceptional views across the valley. The trees here were cleared following storm damage and site has been left to regenerate. This area has become wild and overgrown but presents an opportunity to scrief and replant a substantial area of commercial trees.


#### **METHOD OF SALE**


Perthybu Wood is offered for sale by Private Treaty. Prospective purchasers should register their interest with the Selling Agents to whom offers should be submitted.


