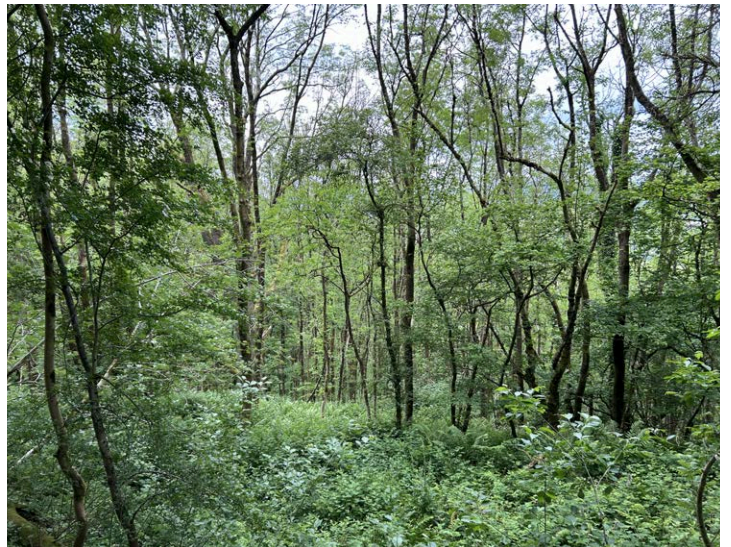

LOCATION

Six Yews Wood is located just to north of the village of Cross Ash in Monmouthshire, 9 miles north-west of Monmouth, 10 miles north-east of Abergavenny and 19 miles south-west of Hereford. All distances are approximate.

DESCRIPTION

Forming part of a larger woodland complex and occupying a scenic location on a west facing slope, Six Yews Wood is a compact but productive woodland.

Featuring both conifers and broadleaves, the conifer element accounts for a little over half of the wood and features primarily mature Sitka spruce with a small area of larch in the southern tip alongside several Scots pine. The spruce has grown very well and shows good form and could now be felled offering a prospective purchaser immediate tax-free income.

The remainder of the wood comprises broadleaves including silver birch, ash and oak.

The majority of the wood is classified as ancient woodland indicating that the majority of the wood has had trees growing continuously since before 1600 AD.

The popular Three Castle Walk route, which runs between Grosmont Castle, Skenfrith Castle and White Castle, runs alongside the eastern boundary of the wood.

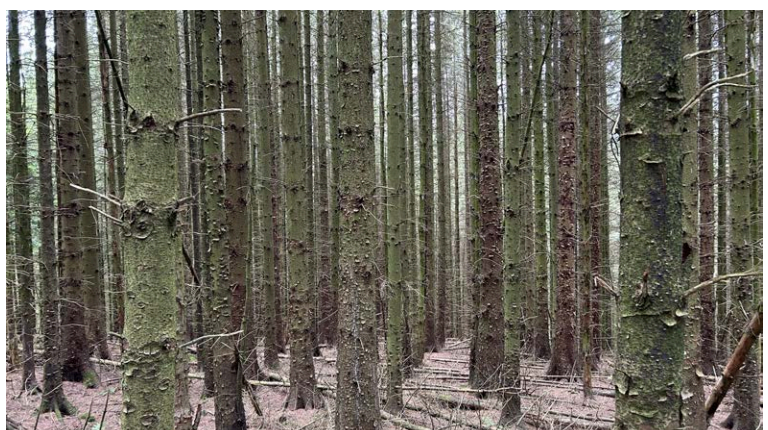

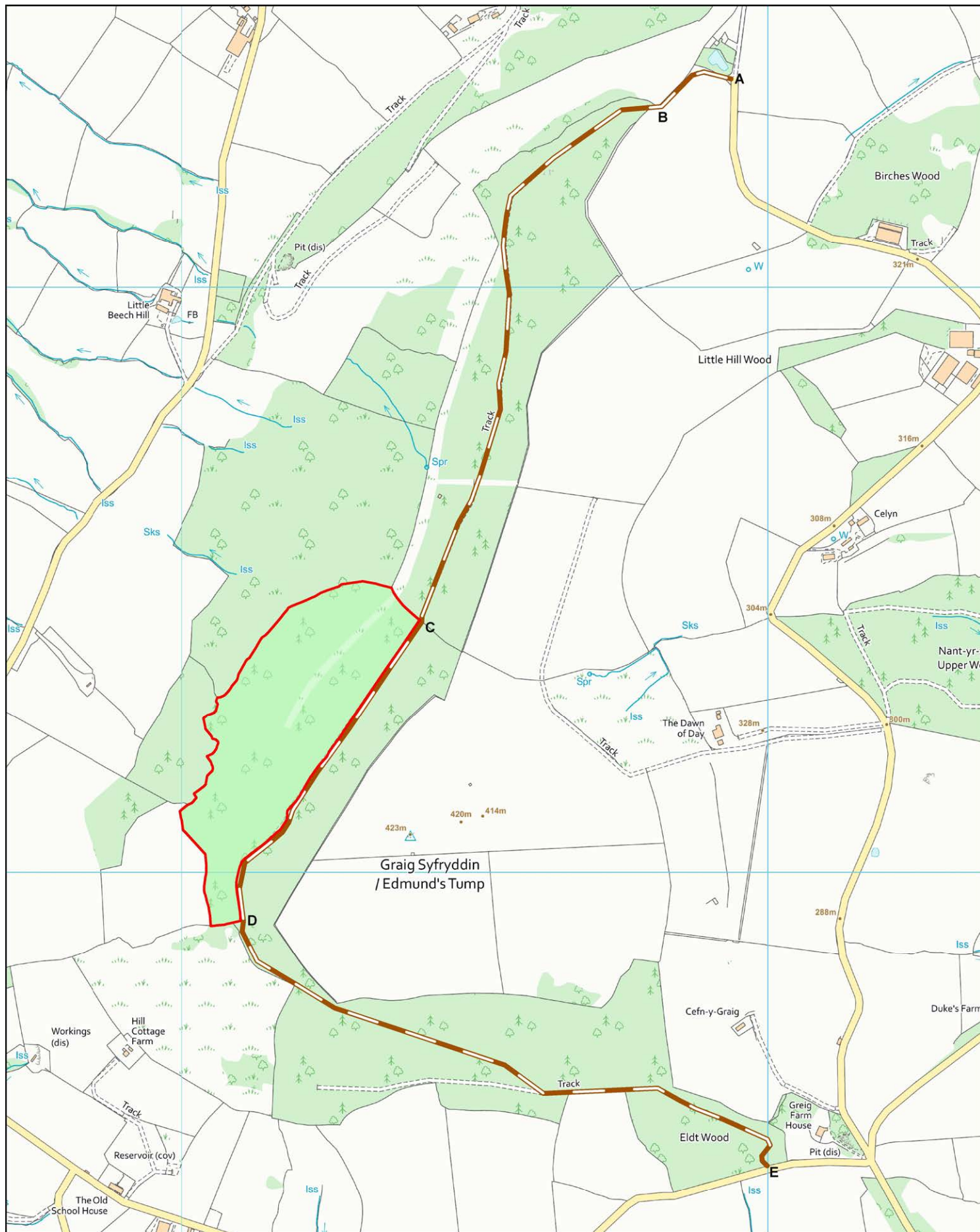
METHOD OF SALE
